18-185 Call to Order

Sue Graham-Nutter called the meeting to order at 6:00 p.m.

Ms. Graham-Nutter gratefully acknowledged that the Toronto Reference Library is on Indigenous land. She indicated this is the traditional territory of the Haudenosaunee Confederacy (also known as the Six Nations Confederacy), the Wendat, and the Mississaugas of the New Credit First Nation. Toronto Public Library gratefully acknowledges these Indigenous nations for their guardianship of this land. Ms. Graham-Nutter reminded and reaffirmed as Torontonians and Canadians, accountability to these Indigenous nations, and to all Indigenous peoples and communities living in Toronto.

Ms. Graham-Nutter further indicated that this land is also part of the Dish with One Spoon territory, that includes a treaty between the Haudenosaunee Confederacy, the Anishinaabek and allied nations, to peaceably share and care for this land, its waters, and all of the biodiversity in the Great Lakes region. All those who come to live and work here are responsible for honouring this treaty in the spirit of peace, friendship, and respect.

Pam Ryan, Director, Service Development & Innovation, introduced Alex Carruthers, Manager, Learning and Community Engagement; Gail MacFayden, Area Manager, Toronto Public Library; Tobias Novogrodsky, Director, Employment and Social Services; and Jennifer Posthumus, Program Support Manager, Toronto Employment and Social Services, City of Toronto.

The Board was provided with information on the partnership between Toronto Public Library (TPL) and Toronto Employment and Social Services (TESS), including two recent projects: community librarianship and Let's Learn Tech.

Community librarians work with vulnerable communities at their point of need, in this case in TESS offices. This allows librarians to learn about and understand distinct information needs and respond by providing the best possible mix of library services and programs.

The Let's Learn Tech project increases access to technology and positions TPL as the home for self-directed and lifelong learning through free online Cisco Networking Academy courses to people facing a financial or social barrier. In-person support is provided as well.

1. *awards the contract to IntelliGO Networks Inc. for the supply of wireless service solution, including hardware, software, installation, technical support, the ability to support authentication and communications and promotions targeted to library customers, and the associated ongoing maintenance costs and estimated cost of Internet communication services, for a three-year term with an option, at the sole discretion of the City Librarian, for two one-year extensions, with a total value of award of approximately \$2,000,902 excluding Harmonized Sales Tax (HST), which is comprised of:*
 - i. *capital implementation costs estimated at \$340,000, plus a capital contingency of \$50,000, for a total of \$390,000; and*
 - ii. *total operating costs over the period from 2019 to 2023 estimated at \$1,610,902.*
2. *approves that IntelliGO Networks Inc. be the vendor of record for any additional requirements for hardware, software, maintenance and professional services for the full term of the contract.*
