### RE: 2011 STRATEGIC PLAN WORK PLAN

At the March 1, 2011 meeting the library board members will be asked to approve the 2011 Strategic Work Plan as found in Agenda Item 13 Staff Report for approval.

The Union would like to comment on two items:

See Theme Five: Supporting a Sustainable Library; Subsection: Ensure Sustainability of Staff Resources. (p 11) There is no mention of ensuring that a staffing model is in place that allows service delivery to be maintained. It is the opinion of the TPLWU Local 4948 that, taking into consideration the 10% cut to the staffing levels since amalgamation, the current staffing model is **no** longer sustainable. Despite repeated attempts over the years to gather data on this issue, senior management continues to maintain that they do not have an organization chart which reflects their plans for the future.

See Theme One: Engaging Diverse Communities – In the City and Our Neighbourhoods. (p. 2 of report) It is stated that youth are going to be supported by providing high quality volunteer opportunities and in Theme Five: Supporting a
