



CULC/CBUC Honoured to be Recognized for the Establishment of the Centre for Equitable Library Access

TORONTO – November 26, 2014 – On Friday, November 21st the CNIB presented the Canadian Urban Libraries Council (CULC/CBUC) with the Dr. Dayton M Forman Memorial Award for their key role in establishing the Centre for Equitable Library Access (CELA) and the removal of barriers for people with print disabilities.

The partnership between CULC/CBUC and CNIB was pivotal to achieving the long-standing vision of CNIB to see equitable library service for people with print disabilities delivered through Canada's public libraries.

"CELA works for the more than three million Canadians with print disabilities, providing equitable access to library materials through their public libraries," said John M. Rafferty, President and CEO, CNIB. "No one should have to rely on a charity for library access – CULC/CBUC's determination and hard work in the launch of CELA is helping make this a reality."

Selection Committee Co-Chair Joan Robinson read in braille the Award citation at the presentation event:

This award is given in recognition of outstanding leadership in the advancement of library and information services for Canadians living with vision loss or print disabilities. This year the award is given to CULC for the creation of the Centre for Equitable Library Access (CELA). The CULC collaborative partnership with CNIB was pivotal to achieving the long standing vision of CNIB to see equitable library service for people with print disabilities delivered through Canada's public libraries. This year's award is a celebration of a courageous coming together of organizations, agencies, professionals, and volunteers with a common purpose: equitable library service for ALL Canadians.

"CULC/CBUC is grateful for this recognition," said Maureen Sawa, Chair of CULC/CBUC. "We are fully committed to ensuring that everyone in the country has the ability to access reading materials in the format of their choice through their local public library"

On accepting the Award on behalf of CULC/CBUC Past Chair Catherine Biss had this to say, "Equitable library service must be accessible to everyone through their local public library, and through CELA this is becoming a reality. We value CNIB's almost 100 years of service and it's because of this that CELA has a strong, robust foundation upon which to build a new pan-Canadian service," said Biss. "We thank CNIB for recognizing our efforts to date, and we know that together we will build something special that will make an enduring difference in people's lives."

Former CNIB Library Chairperson Jane Beaumont, as part of the presentation, read a few words from Dr. Forman's daughter Janet Forman. "I wish my father could see what the Canadian Urban Libraries Council has accomplished. When I read the vision statement of the Centre for Equitable Library Access, I instantly pictured Dad smiling with approval – and appreciation."
