

Summary of Fines Changes implemented in 2012

Fine structure

As of January 3, 2012, fines are charged based on the type of material customers borrow – adult, teen or child – not on cardholder's age category. For example, adults who borrow children's material are charged child rates for any overdue items. Teens who are late returning adult materials are charged adult rates.
