

2022 Interim Budget Estimates

SUMMARY

The purpose of this report is to seek Toronto Public Library Board adoption of the 2022 interim operating and capital budget estimates, subject to Council approval, in order to provide necessary spending authority to deliver current services, meet existing contractual commitments and continue work on previously approved capital projects during the period between January 1, 2022 and the date on which Council approves the 2022 operating and capital budgets.

The interim 2022 operating budget for Toronto Public Library (TPL) is \$66.152 million gross (\$60.915 million net), which is based on 30% of TPL's 2021 Council-approved budget.

The interim capital budget is \$20.035 million gross (\$14.423 million debt), which is based on carry forward funding from 2021 and 30% of the 2022 funding commitments for previously approved capital projects.

Council approval of the 2022 interim budgets is expected in December 2021, and Council approval of the 2022 budgets is expected in February 2022.

RECOMMENDATIONS

The City Librarian recommends that the Toronto Public Library Board:

1. adopts the 2022 interim operating budget of \$66.152 million gross (\$60.915 million net), subject to Council approval; and

- adopts the 2022 interim capital budget of \$20.035 million gross (\$14.423 million debt), subject to Council approval.

FINANCIAL IMPACT

The 2022 interim operating budget for TPL is \$66.152 million gross (\$60.915 million net), which is based on 30% of TPL's 2021 approved operating budget.

The interim capital budget is \$20.035 million gross (\$14.423 million debt), which is based on carry forward funding from 2021 and 30% of the 2022 funding commitments for previously approved projects.

TPL's interim budget percentage approvals are consistent with other City Agencies and Divisions and is expected to be more than adequate to meet TPL's operating and capital needs in the interim period.

The Director, Finance & Treasurer has reviewed this financial impact statement and is in agreement with it.

COMMENTS

In accordance with TPL's Financial Control Policy, prior to the approval of the annual operating and capital budgets, the Library Board needs to adopt the Council-approved interim estimates. The approval of the 2022 interim budget funding will provide necessary spending authority to deliver current services, meet existing contractual commitments and continue work on previously approved capital projects during the period between January 1, 2022 and the date on which Council approves the 2022 operating and capital budgets, expected to be in February 2022.

Expenditures made during the period from January 1, 2022 to the date Council approves the 2022 operating and capital budgets must be restricted to the delivery of current approved service levels, existing contractual commitments and to continue work on previously approved capital projects.
