- (b) the celebration of the 30th anniversary of the Library's famous Arthur Conan Doyle and Sherlock Holmes collections at the Toronto Reference Library. To honour the occasion, TPL is hosting *Footprints of the Hound*, an international symposium of the works of Conan Doyle;
- (c) *A Novel Afternoon*, the TPL Foundation's gala luncheon to raise funds for the Library's literacy programs. At this event the creators of the beloved storybook character, *Franklin the Turtle*, will be honoured;

During October, TPL staff will conduct an intercept survey of 1,450 Library users to expand upon the findings of the public opinion research. The results will be reported to the Board at a later date.
