Gillian Mason reported the following details regarding Library activities:

- (a) TPL's *Kindergarten Outreach Program* was launched at the Lillian H. Smith Branch on April 2 featuring Toronto Poet Laureate Dennis Lee.
- (b) A profile of the Osborne Collection appeared in the March 24 weekend edition of the *Globe and Mail*.
- (c) News concerning a recent \$12,500 donation from the Rotary Club was featured in the March 24 edition of the *Scarborough Mirror*.
- (d) Roch Carrier, National Librarian, visited the Toronto Star Newspaper Centre at TRL on March 7.
- (e) A recent donation by George Weston Limited to Special Collections includes 30 maps, charts and illustrations, dating from 1574 to 1893 depicting key explorations and discoveries of Canada's northern and Arctic regions. Included is a late 17th century map by Coronelli, the first printed map of the North Pole.
- (f) More than 17,000 children attended 252 March Break programs, an increase of six percent since 2000.
- (g) The final Performing Arts Lecture for the 2001/2002 season will be by well-known Canadian playwright Dan Needles. Planning for the next season is well underway.
- (h) The opening reception for *This Magical Book* will take place on April 12 at 6:00 p.m. in the Canada Trust Gallery at the Toronto Reference Library. The exhibit will feature children's pop-up and other movable books from the Osborne Collection.

**02-74 Purchase of Electricity Agreement***Moved by M. Weisberg, seconded by Councillor Minnan-Wong, and carried:**That:*

- (1) *The Toronto Public Library Board (TPLB) appoint the City of Toronto as its Agent for the purposes of:*
  - (a) *Negotiating the electricity purchase agreement with Toronto Hydro Energy Services Inc. (THESI) for TPLB's estimated pro rata share of electricity based on TPLB's past consumption patterns;*
  - (b) *Executing the Master Agreement (among THESI, the City of Toronto, The Toronto Transit Commission, and Toronto Community Housing Corporation and those Agencies, Boards, Commissions and Corporations on whose behalf the City is appointed Agent) dated as of April 2002 and any Transactional Agreements for the purchase of various blocks of power on behalf of TPLB;*
  - (c) *Administering the Master Agreement and any Transactional Agreements, including monitoring any excess sell-back of electrical power or instructing THESI with respect to the acquisition of electrical power to meet shortfalls in the contracted amount on behalf of TPLB, subject to the terms and conditions of those respective Agreements;*

**Purchase of Electricity Agreement (continued)**

- (d) *Receiving monthly invoices and detailed statements of consumption for both the distribution portion and retail portion of TPLB's electricity usage, as well as any ancillary charges, under THESI's Retailer-Consolidated Billing arrangements with Toronto Hydro Electric System Limited;*
- (e) *Paying the amounts invoiced to THESI within 24 hours of receipt on behalf of TPLB;*
- (f) *Forwarding TPLB's portion of the invoice to TPLB forthwith for review and approval by TPLB;*
- (g) *Receiving payment from TPLB of TPLB's pro rata share of the invoiced amount within fifteen (15) days of the City's payment to THESI on TPLB's behalf; or, alternatively, deducting TPLB's payment from monies which the City would otherwise transfer to TPLB as part of the annual budget approval process;*
- (h) *Providing notification to THESI of any disputes raised by TPLB with respect to TPLB's invoice and taking any necessary steps to enforce TPLB's rights under the Master Agreement and Transactional Agreements;*
- (i) *Doing such other things as are necessary to implement the Master Agreement and any Transactional Agreements on behalf of TPLB.*

(2) *TPLB will pay City of Toronto for all amounts paid on TPLB's behalf within the agreed upon time period, failing which City of Toronto shall deduct amounts owing from any funds under the care and control of City Treasurer which have been allocated by City for TPLB and not yet paid to TPLB; and failing such recovery of funds, City shall take any necessary action to enforce payment against TPLB;*

(3) *The City and TPLB shall each indemnify the other with respect to claims, damages, etc. attributable to any negligent or willful act or omission by one or the other party with respect to the performance of the Agency Agreement, the Master Agreement or any Transactional Agreement.*
